One payment to be made by the bride for total services rendered after deposit. Consultation appointments are essential for the bride. One hour is scheduled for a *complete* walk-through of the style. Consultation should be scheduled prior to your big day!

CANCELLATIONS

Please be advised that cancellations or modifications to the appointments must be made no later than 7 days before the scheduled appointment.

RIGHT OF REFUSAL

Due to liability and safety concerns, we have the right to refuse service without refund for *over* intoxication, rude behavior and demeaning vulgar language.

WEDDING DAY

- In order to ensure you receive the service you deserve, please arrive on time.
- Please shampoo your hair the day before. We do not recommend shampooing the day of.
- Please ask all members of your party to use only soft styling sprays in the morning, as hard sprays make hair hard to curl and style. Be sure to wear a shirt that is easily removed, preferably a button-down the front shirt.
- Gratuity is not included in packages or set prices. 15-20% is traditionally given for any service.
